PM visiting Gujarat on Saturday

New Delhi : The Prime Minister will visit the newly built Matushri K.D.P. Multispecialty Hospital in Atkot, Rajkot where he will address the public there.

According to the Prime Minister's Office, the cooperative sector of Gujarat is ideal for the whole country. There are more than 84,000 societies in the cooperative sector of the state.

About 231 lakh members are associated with these societies. In order to further strengthen the cooperative movement in the state, a seminar of heads of various cooperative institutions is being organised on the theme 'Sahakar Se Samridhhi', which will be held at Mahatma Mandir, Gandhinagar.

In an effort to provide farmers with a means to increase their productivity and help them increase their income, the Prime Minister will also inaugurate a Nano-urea

(liquid) plant at IFFCO Kalol constructed at a cost of about Rs 175 crore. The state-of-the-art Nano Fertilizer Plant has been set up keeping in mind the goal of increasing crop yield using Nano-urea.

The Matoshree KDP Multi-Specialty Hospital, which the Prime Minister will visit, is managed by Shree Patel Seva Samaj. The hospital will be equipped with state-of-the-art medical equipment and will provide world class healthcare facilities to the people of the region.

New Delhi : Prime Minister Narendra Modi and Congress President Sonia Gandhi and other party leaders paid tributes to the country's first Prime Minister Jawaharlal Nehru on the occasion of his 58th death anniversary on Friday.

The Prime Minister paid his tribute to former Prime Minister via a tweet, "Tributes to Pandit Jawaharlal Nehru Ji on his death anniversary." Former Congress President

Rahul Gandhi, wrote that his thoughts are relevant even 58 years after Nehru's death.

Congress National Spokesperson Randeep Surjewala wrote - tributes to the creator of modern independent India and the first Prime Minister of India, who took India forward in scientific, economic, industrial and various fields, Bharat Ratna Pandit Jawaharlal Nehru on his death anniversary.

Nehru was born on November 14, 1889 in Allahabad. He died on May 27, 1964, due to a heart attack. Nehru served as Prime Minister for about 17 years.
